❖ *Admission process:*

- GNM– Through “ **West Bengal Joint Entrance Examination Board**” online portal. Candidate must qualify and obtain rank in the “**Joint Entrance Examination For ANM (R) and GNM**” as decided by **Health And Family Welfare Department, Government of West Bengal** with collaboration of **West Bengal Joint Entrance Examination Board** .
- **Post Basic Diploma in Oncology Nursing** - Through offline process by application.

◆ **Every year academic fees to be paid at the beginning of new academic year**

Charges Not Included In Course Fees are:

1. Uniforms
2. Books
3. Outside Clinical field expense fees as per curriculum
4. Council Examination
5. SNA Activities
6. Registration (Student+Final)
7. Mark sheet Verification

Money to be paid during admission is Rs. 1,26,000/- (One Lakh twenty six thousand).

Breakup of the fees are :

- i. 1st year academic fees -Rs. 96,000/-
- ii. Transportation fees for 3 months- Rs. 6000/-
- iii. Food & Boarding fees for 3 months- Rs.24,000/-

❖ Mode of Payment:

Course fees- Must be paid in the form of Demand Draft in favor of **“ASIA HEART FOUNDATION” payable at Kolkata.** Academic Fees will be taken at the time of starting of new academic year.

No amount of money is refundable in any circumstance in addition.

NOTE:

In case of extension of course due to supplementary examination the requisite course fees & hostel fees are to be borne by the candidate.

❖ Cancellation of admission:
