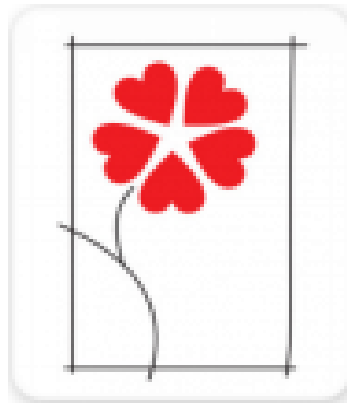

Rules For Fees submission:

- ✓ Academic Fees will be taken at the time of starting of every new academic year.
- ✓ No money is refundable in any circumstance.

NOTE:

In case of extension of course due to supplementary examination, the requisite course fees inclusive of Transport & Hostel Food & Lodging fees must be borne by the candidate in addition.

❖ **Cancellation of admission:**

The Institute have the right to cancel any admission and / or studentship of any student during the session if she is found guilty of any of the following charges:

- 1. Suppression of information.*
- 2. Supply of false documentations.*
- 3. Medically & Mentally unfit.*
- 4. Discrepancy in mark sheet after verification by the concerned Board*
- 5. Any other reason as deem fit by WBNC*

Rules & Regulation:

❖ SCHOOL

- 1. All students are required to be punctual and are not allowed to be absent from classes without genuine reason and without prior permission from the class teacher and Principal/Vice-Principal of School of Nursing.**
2. Students must be in recommended uniform in the clinics, community and in the classroom.
3. No visitors & mobile phones are allowed during class as well as duty hours, except in emergency.
4. Each student is responsible to pay all the examination fees and fees for special clinical exposure as per curriculum

❖ HOSTEL

1. It is mandatory for all students to reside in the hostel provided by the institution.
2. Students are not allowed to keep any valuables like jewellery, expensive mobile phones in the hostel. Students are solely responsible for their personal belongings.
3. Hostel articles must be returned at the time of final departure from the hostel. Clearance will be given after that as well as after completion of each academic year student must return their previous year academic belongings which will not be used in recent year.
4. Rooms and beds shall be allocated by the Hostel In charge and no personal preference will be entertained.
5. Overall cleanliness of the room is to be maintained by the students residing in the hostel.
6. Pasting Stickers & writing on the walls and furniture are not allowed. As and when it is found the caution money will be deducted for repairing the walls and furniture.
7. No furniture to be moved from the room.
8. Students are not permitted to use any electrical appliance other than light & fan, which are provided from the hostel and mobile phone.
9. Pasting Stickers & writing on the walls and furniture are not allowed. As and when it is found the caution money will be deducted for repairing the walls and furniture.
10. No furniture to be moved from the room.
11. Students are not permitted to use any electrical appliance other than light & fan, which are provided from the hostel and mobile phone.
- 12. Use of candle / Agarbatti or any other fire consumables/open fire are strictly prohibited.**
13. Fans & lights to be switched off before leaving the rooms.
14. No visitors are allowed in student's rooms.

15. **Visiting hours:** - Visitors are allowed to meet their wards only on **Saturday from 4 pm to 6 pm and on Sunday from 10 am to 12 noon ,4 pm to 6 pm** at Visitor's room of hostel.
16. Students can go outside from 9 a m to 5 pm after getting permission from respective class co-ordinator & documentation (signature) in the outgoing register in the hostel. (only on Public Holidays & Sundays,) with permission of Hostel Warden.
17. Disciplinary action will be taken in case if any student leaves the hostel without documentation and permission.
18. Students are not allowed to come out from their room with In-decent Dresses.
19. Smoking & consumption of alcohol, gutkha & other similar substances are strictly prohibited.
20. Strict action will be taken against the students if rules are violated.
21. Serious Disciplinary action will be taken against the student found absent from the hostel without any information.

❖ **SICKNESS RULES**

- 1) If any student falling sick at hostel—sickness must be reported and recorded to the warden by the sick student/roommate
- 2) No students are allowed to stay at room without reporting the sickness to warden
- 3) Warden will seek necessary medical assistance from the Hospital
- 4) **Self medication is strictly prohibited.**
- 5) In case of major illness/hospitalization information will be sent & guardian must attend as soon as possible.
- 6) If any student falling sick in the School, clinical field, sickness must be reported to the respective teacher.
- 7) If any student falling sick at home, sickness must be reported to the concerned teacher and field. She should produce treatment card/ prescription and guardian letter, when she will join the college.
- 8) In case any student is under proper medication, it shall be brought to the notice of the authority
- 9) Absenteeism due to sickness for 3 or more days need to produce medical fit certificate to resume normal duty.

Clinical Duties:

Students will have to complete 100% clinical duty to appear in their year wise final examination, conducted by West Bengal Nursing Council as ordered by WBNC & INC.

Student will be posted in different hospital including their mother institute, these are:

- a) Parent Hospital: We have two parent hospital:
 - *Narayana Multispeciality Hospital &*
 - *Narayana Superspeciality Hospital.*
- b) Government hospitals as permitted by Swasthya Bhaban for different subjects

LEAVE & ABSENTISM RULES:

1. Students must adhere to the leave rules as provided by institution.
2. Any special leave may be granted as a Special case by the Competent Authority but the student must make good the duty hours.
3. Students are not allowed to do any unauthorized absenteeism.
4. In case of unauthorized leave or absenteeism, the students must report to the co-coordinator and warden (in case of hostel living) before resuming daily activities with proper justification/Medical Certificate as required
5. After absenteeism, no students are allowed to do daily activities without reporting to the coordinator

LIBRARY RULES

1. Students will be issued two books per 7 days. If the student failed to return within the stipulated time, late fine Rs.10/- per day will be charged.
2. Books cannot be taken out of the library without proper issuance & permission.
3. Any tempering of the books must be notified to the librarian immediately at the time of issuance of the books.
4. For any damage found at the time of returning of an issued Document/Book, the borrower has to pay the cost of the same.
5. In case of loss of books by any student they have to replace the same book of latest edition

Information to the guardians:

1. Guardians are not allowed to make any phone calls/meeting with their wards during class and clinical duty.
2. In case of any emergency, guardian needs to contact to the Principal.
3. If any guardians wish to meet the Principal, appointment must be taken through your ward before hand.
4. Without prior appointment, no guardian will be allowed to meet with Principal except on emergency.
5. Guardian must attend the schedule of Parent Teacher meeting.

Anti ragging Resolution :

RAGGING IS STRICTLY PROHIBITED

1. We have anti-ragging policy based on UGC & INC guidelines to address the ragging issues.
 - Anti ragging committee (Consisting of Head of the institutions, representative of civil & administration, NGOs involved in youth activities, representatives of faculty members, representatives of parents, representatives of students, non teaching staff and chaired by Head of the institution) Quorum shall be formed with the attendance of majority of the members.
 - Monitoring cell (upper level & lower level) comprising of 10 students and 2 teachers.
 - Anti ragging Squad comprising of 10 members. Committee comprising of representatives of faculty members, warden, office staff and coordinated by a teacher selected by principal.
2. If any student experiences any ragging issue, first report of the incident shall be done by the student to the Monitoring Cell at lower level followed by upper level.
3. Every student who takes admission to this institution has to give undertaking in the form of affidavit for making ragging-free campus.
4. Frequent / Periodical supervision & raid in hostel & class room shall be done by the above Committees

Punishment:
